ORDER

1. This Petition has been filed by State Bank of India ('Petitioner'/ 'Creditor')

Financial Creditor, against Mr. Sanjay Maheshwari, Personal Guarantor

CP No. (1B)- 21/121/JPR/2024

('Respondent'/ 'Debtor') of M/s Saga Automotive India Private Limited ('Corporate Debtor'), under Section 121 of the Insolvency and Bankruptcy Code, 2016 ('IBC/Code') seeking initiation of the bankruptcy proceedings apropos the Respondent.

- 2. The Applicant had filed a Petition bearing *CP No. (IB)-49/95/JPR/2021* under Section 95 r/w Rule 7 of the Insolvency and Bankruptcy (Application to Adjudicating Authority for Insolvency Resolution Process ('IRP') for Personal Guarantors to Corporate Debtor) Rules, 2019 ('Rules'), seeking initiation of Insolvency Resolution Process against the Respondent for an amount of Rs. 28,36,04,727.55/- (Rupees Twenty-Eight Cores Thirty-Six Lakhs Four Thousand Seven Hundred and Twenty-Seven and Fifty-Five Paisa Only).
- 3. Thereafter this Adjudicating Authority vide order dated 01.09.2021 had appointed *Mr. Sandeep Mahajan*, bearing Registration No. *IBBI/IPA-001/IP-P00991/2017-18/11631* as Resolution Professional ('RP') for the Respondent/Personal Guarantor and directed the RP to file a report under section 99 of IBC 2016. The RP had filed a report under Section 99 of the Code recommending admission of the Petition filed under Section 95. Thereafter, this Adjudicating Authority vide its Order dated 30.05.2022 admitted the Petition filed by the Creditor and directed the RP to submit the repayment plan under Section 105 of the Code, 2016.

4. Thereafter, the RP in consultation with the Personal Guarantor prepared a repayment plan and the same was rejected by the Creditor. Consequently, the Resolution Professional filed an Application bearing *IA(IBC)* No. 76/JPR/2023 under Section 112 of the Code seeking directions apropos initiation of the bankruptcy process. This Adjudicating Authority vide its Order dated 20.09.2023 disposed the *IA(IBC)* No. 76/JPR/2023 and observed that:

"The Debtor/Creditor shall be entitled to file an application for bankruptcy under Chapter IV. In view of the above provisions of law, RP will file appropriate application under Chapter IV. This IA stands disposed of accordingly."

- The present Petition is filed for seeking initiation of Bankruptcy against the Respondent/Personal Guarantor. The Petitioner has filed this Petition in time and has complied with all pre-requisite requirements as provided under the regulations of Code, 2016. Further, the Petition has been filed in compliance of Section 123(1) of the Code as the Petitioner has filed the relevant orders pertaining to the insolvency resolution process undertaken under Chapter III, a copy of the Order wherein it was directed to file an application for Bankruptcy, and the details of the debts owed by the debtor. Hence, the present Petition filed by the Creditor under the provision of the Code, 2016 is hereby admitted under Section 126 of the Code.
- 6. As a result of that, Mr. Sanjay Maheshwari, resident of 803, Block B

 Guman Eternity, Subhash Nagar, Jaipur, Rajasthan, is ordered to be

Bankrupt. Further, in the Petition, the Creditor has proposed the name of *Mr. Sandeep Mahajan* who is duly registered as an Insolvency Professional with IBBI having registration no. *IBBI/IPA-001/IP-P00991/2017-2018/11631* to act as the Bankruptcy Trustee. Moreover, the written consent of the proposed insolvency professional has also been filed with the Petition under Form-A. Therefore, *Mr. Sandeep Mahajan* is appointed as the Bankruptcy Trustee under section 125 of IBC, 2016.

- 7. The Registry is directed to provide a copy of this Bankruptcy order and a copy of the Bankruptcy Application to the Bankrupt, the Creditor and the Bankruptcy trustee within seven days as provided under Section 126 (2) of IBC, 2016.
- 8. This order of Bankruptcy shall remain in force till the Debtor is discharged under section 138 of IBC, 2016.
- 9. The Bankrupt shall submit her statement of financial position to the Bankruptcy Trustee in the prescribed Form within seven days from the date of the order.
- 10. The estate of the Bankrupt excluding the assets mentioned in Section 155(2) of Code shall vest with the Bankruptcy Trustee in pursuance of this order. The Bankruptcy Trustee is directed to forthwith take into his custody all the assets, Properties, and actionable claims of the Bankrupt and take necessary steps to ensure the preservation, protection security, and

maintenance of those properties as provided under Sections 128 and 154 of IBC, 2016.

- 11. The Bankruptcy Trustee is directed to adhere to Sections 128, 129 (4), 132 133, 134, 136, and 137 of IBC, 2016 and discharge his powers and duties as specified under Rules and Regulations issued by IBBI in this regard from time to time.
- 12. The Bankruptcy Trustee for the Adjudicating Authority shall send notices as provided under section 130 (1)(a) of IBC, 2016 within ten days from the date of this order to the creditor mentioned in the statement of affairs submitted by the Bankrupt under section 129 of IBC, 2016.
- 13. A Public Notice inviting claims from the creditors as contemplated under section 130 (2) of the Code shall published in leading newspapers (One English and One Hindi) having wide circulation in the area where the Bankrupt resides. The publication shall comply with the requirements mentioned in Section 130 of the Code and the other relevant provisions.
- 14. On the passing of the Bankruptcy order but subject to sub-section (2) of Section 128 of the Code, the creditor shall not initiate any action against the property of the Bankrupt in respect of a debt, and no suit or other legal proceeding shall be initiated against the Bankrupt, save and except with the permission of this Adjudicating Authority as provided in Section 128 (c)(ii) of the Code.

- 15. The Bankruptcy Trustee shall conduct the administration of the distribution of the estate of the Bankrupt under Chapter V as provided in Section 136 of the Code, 2016.
- 16. The Bankrupt shall from the date of the order be subject to such disqualifications and restrictions as prescribed under Sections 140 and 141 of the code.
- 17. The Bankruptcy Trustee may seek such further information or explanation in connection with the bankruptcy process as may be required from the debtor or the creditor or any other person who in the opinion of the Bankruptcy Trustee, may provide such information. The persons from whom such information or explanation is sought shall furnish the same within seven days of receipt of the request.
- 18. The Bankruptcy Trustee shall exercise all the powers as enumerated under the Code read with Rules and Regulations made thereunder.
- 19. The Bankruptcy Trustee shall submit to this Adjudicating Authority and committee a preliminary report within ninety days from the date of the Bankruptcy order after serving a copy of the report on bankruptcy as provided in Regulation 8 of Insolvency and Bankruptcy Board of India (Bankruptcy Process for personal Guarantors to Corporate Debtors) Regulation, 2019.
- 20. The Bankruptcy Trustee shall submit to this Adjudicating Authority a periodical progress report within fifteen days after the end of every quarter

- 21. The fee of the Bankruptcy trustee shall be paid in accordance with the Regulation 4 of Insolvency and Bankruptcy Board of India (Bankruptcy Process for Personal Guarantors to Corporate Debtors) Regulation, 2019.

- 23. A certified copy of the order is to be issued upon compliance with requisite formalities.



Minutes of 1st meeting of Creditors of Mr. Sanjay Maheshwari-in Bankruptcy Process (being the Personal Guarantor to the Corporate Debtor, Saga Automotive India Private Limited) under Insolvency and Bankruptcy Code, 2016 ("Code") held on Wednesday, 18th June 2025, through video conferencing /Audio and Visual means at the scheduled venue Office of ARCK Resolution Professionals LLP at 409, 4th Floor, Ansal Bhawan, KG Marg, New Delhi-110001

Meeting commenced at: 05:00 P.M. Meeting concluded at: 06:15 P.M.

Participants Present:

As per attendance sheet annexed.

The meeting was convened and chaired by Mr. Sandeep Mahajan, the Bankruptcy Trustee (hereinafter referred to as "Bankruptcy Trustee" or "undersigned") and was attended by the representatives of the Creditors ("Creditors") and the team of Bankruptcy Trustee. The Personal Guarantor, Mr. Sanjay Maheshwari also attended the meeting (hereinafter collectively referred to as "Participants"). All the participants attended the meeting through audio and visual facility through zoom application.

Quorum

The Bankruptcy Trustee apprised the participants regarding the provision of Section 134(2) of the Code which requires the Bankruptcy Trustee to decide the Quorum of the meeting. It was proposed by the Bankruptcy Trustee that the quorum the meetings of the Committee of Creditors was decided to be fixed at 50% of voting share of the creditors.

Thereupon, the Bankruptcy Trustee ("BT") requested all the participants to mark their presence through the chat box by furnishing their name, contact no., email id, the capacity in which they are attending and the creditor they are representing in the meeting. After the roll call, the BT informed the participants the names of all the persons who were present in the meeting and apprised that there being presence of both the creditors in the meeting as appearing in the List of Creditors through Audio/Video mode, the quorum requirement stood satisfied.

The participants were already provided with copies of the notice & agenda, progress report and other documents for consideration and discussion purposes through email, which they confirmed at the time of roll call. The said documents were also displayed on the shared screen of video conferencing application to the participants.

The Meeting started with Mr. Sandeep Mahajan, Bankruptcy Trustee, welcoming the participants and a brief round of introduction. Further, the participants were requested to ensure that no one other than the members/creditors marking their presence is attending the meeting or has access to the proceedings of the meeting at the location of that member.

He then read out the agenda for the meeting as provided and agenda items were taken up for consideration in SERIATIM, as follows-

A. Matters of discussion:

1. The Bankruptcy Trustee to take the Chair

As per Regulation 23(1) of the Insolvency and Bankruptcy Board of India (Bankruptcy Process for Personal Guarantors to Corporate Debtors) Regulations, 2019 ("Bankruptcy Process Regulations"), the Bankruptcy Trustee shall act as the Chairperson of the meeting of the Committee. Accordingly, the Bankruptcy Trustee took the chair and proceeded with the meeting.

2. To decide and ascertain the quorum of the Meeting in accordance with the provisions of Section 134 (2) of the Code

To recap, the Bankruptcy Trustee apprised the participants regarding the provision of Section 134(2) of the Code about deciding of quorum by the BT, decision about fixation of quorum of all the meetings of the Committee/Creditors at 50% of voting share of creditors and presence of both the creditors in the meeting. Hence, the BT quorate the meeting.

3. To apprise, place & take note of the list of creditors and voting share of creditors as per section 132 of the Code, prepared by Bankruptcy Trustee

The Bankruptcy Trustee apprised that Hon'ble NCLT vide its order dated 26.05.2025 has initiated the bankruptcy process against Mr. Sanjay Maheshwari, being Personal Guarantor ("PG") to the Corporate Debtor, M/s Saga Automotive India Private Limited, under Section 126 of the Code and appointed the undersigned as Bankruptcy Trustee to conduct the process vide the same order. Upon receipt of the order, as uploaded on the website of Hon'ble NCLT, the undersigned had issued and got the Public Notice published in stipulated Form C on 30.05.2025 in The Indian Express (In English-Delhi/NCR editions) and Prabhat Abhinandan (In Hindi- Delhi/NCR editions) inviting claims from all the creditors of the PG till its last date fixed as 06.06.2025 (within 7 days of the public notice) in accordance with the provisions of the Code.

It was further apprised that SBI and IDBI have submitted their respective claims in stipulated Form-F in the Bankruptcy Process of the PG (i.e. Mr.

Sanjay Maheshwari of Corporate Debtor- M/s Saga Automotive India Private Limited) under cover of their respective email dated 06.06.2025.

Upon receipt of the claims from the two creditors, the Bankruptcy Trustee duly verified the claims with the documents provided by the respective claimant as well as documents available with the Bankruptcy Trustee as received during personal insolvency resolution process ("PIRP") of the PG well within the timelines provided in the Code and prepared a list of creditors as on 11.06.2025 in terms of Section 132 of the Code read with Regulation 20 (1) of Bankruptcy Process Regulations. The List of Creditors was thereafter placed before the Creditors/Committee by displaying the same on the shared screen of video conferencing application. It was further apprised that the undersigned vide e-mail dated 11.06.2025 duly shared the List of Creditors with both the creditors, being members of the meeting and also with the PG. It was added that in compliance of Section 171 of the Code, creditors were requested to provide the following documents/information within 14 days of preparing the list of creditors in reference to the claim submitted: -

- 1. Excel Calculation Sheet of the claim amount having details of principal amount, interest components, penal interest and other charges if any.
- 2. Any other documents in support of the claim.

The undersigned again requested the creditors to provide excel sheet having calculation of interest, penal interest charged and also the supporting documents for interest charged.

The members took note of the same.

4. To discuss consider and resolve on the establishment of a Committee of Creditors in accordance with Section 134 (3) (a) of the Code

It was apprised that as per Section 134 (3) of the Code, the following business shall be conducted in the meeting of the creditors in which regard a resolution may be passed, namely: –

(a) the establishment of a committee of creditors;

(b) any other business that the bankruptcy trustee thinks fit to be transacted.

Accordingly, it was proposed by the BT that as per the provisions of the Code and Regulations made thereunder, the committee of creditors be established comprising both the creditors whose claim has been admitted provisionally. A resolution to this effect, as under, was moved by the undersigned:

"RESOLVED THAT pursuant to Section 134(3) of the Code, the committee of creditors be established comprising both the creditors whose claim has been admitted provisionally, i.e. SBI with 99.00% of voting share and IDBI with 1.00% voting share."

The above resolution was approved by both the Creditors.

The same was taken note of.

5. To apprise CoC about the status/progress of Bankruptcy Process conducted till date and to discuss on the way forward.

The Bankruptcy Trustee then walked the CoC through the progress report outlining the steps taken by him to conduct bankruptcy process of the PG since his appointment, which are as under in brief-

(a) Creation of Process specific email id

The Bankruptcy Trustee has created a process specific e-mail id for the purpose of communicating with all the stakeholders including the Personal Guarantor so as to ensure reliability and more responsiveness towards the stakeholders. The client specific email id created in the matter is pg.saga260525@outlook.com.

(b) Public Announcement made by the Bankruptcy Trustee-

It was apprised that the Bankruptcy Trustee pursuant to his appointment vide order dated 26.05.2025 passed by Hon'ble National Company Law Tribunal ("Hon'ble NCLT") sought quotations for issuing/publishing Public Announcement in stipulated FORM C. Pursuant to the receipt of the quotations, the undersigned through the L1 publisher, M/s Falcon Advertisers, had made a public announcement in Form- C on 30.05.2025 in accordance with Section 130(1)(b) read with ("r/w") Section 130(2) of the Code wherein the last date for submission of the claims was stipulated as 06.06.2025 as per Section 131 of the Code.

In accordance with Section 130(2)(a) of the Code, the Form- C was published in the following newspapers:

- (i) Indian Express In English
- (ii) Prabhat Abhinandan In Hindi

The copies of the public announcement were also shared with the creditors vide e-mail dated 30.05.2025 and have also been uploaded on the website of ARCK Resolution Professionals LLP- IPE of which the Bankruptcy Trustee is a Partner. i.e. www.arck.in.

(c) Intimation to Registrar of Hon'ble NCLT

The undersigned apprised that vide e-mail intimated Registrar of Hon'ble NCLT about the initiation of the Bankruptcy Process. He was requested vide the same email to affix the public announcement in the premises of the Hon'ble Adjudicating Authority and place the same on the website of Adjudicating Authority in accordance with Section 130 (2) (b & c) of the Code.

(d) Intimation to IBBI and IPA of the Bankruptcy Trustee-

The undersigned has intimated the initiation of the Bankruptcy Process against Personal Guarantor of Corporate Debtor, Mr. Sanjay Maheshwari of Corporate Debtor- M/s Saga Automotive India Private Limited to IBBI and IPA of the Bankruptcy Trustee vide e-mail dated 30.05.2025.

(e) Intimation to Bankrupt/Personal Guarantor (PG) and request to submit Statement of Financial Position

The undersigned vide e-mail dated 30.05.2025 apprised the PG, i.e. Mr. Sanjay Maheshwari of Corporate Debtor- Saga Automotive India Private Limited, about the initiation of Bankruptcy Process against him vide Hon'ble NCLT order dated 26.05.2025. The undersigned further apprised the PG about compliance of Section 129(1) of the Code read with Rule 11 of the Insolvency and Bankruptcy (Application to Adjudicating Authority for Bankruptcy Process for Personal Guarantors to Corporate Debtors) Rules, 2019 ("BPPG Rules") and requested to share his **Statement of Financial Position** with the undersigned within **7 days** of the commencement of the Bankruptcy Process, i.e., latest by 01.06.2025 in the prescribed format i.e. Form- E which was also shared by the undersigned for convenient reference of the PG. The said provision i.e. **Section 129(1)** of the Code and **Rule 11** of BPPG Rules was read over, as under:

Section 129 (1)"...Where a bankruptcy order is passed on the application for bankruptcy by a creditor under section 123, the bankrupt shall submit his statement of financial position to the bankruptcy trustee within seven days from the bankruptcy commencement date..."

Rule 11of BPPG Rules, 2019- "Statement of financial position. — The statement of financial position referred to in sub-section (2) of section 129 shall be submitted by the bankrupt, in **Form E**."

The PG was called upon vide this letter dated 30.05.2025 to undertake all the required steps and actions regarding the assets listed in Statement of Affairs submitted by him during the insolvency resolution process, including but not limited to the following:

- i. Submit the Statement of Financial Position in Form E as requested vide our letter/ email
- ii. Handover custody/ possession/ control of all his assets, properties& actionable claims to the undersigned bankruptcy trustee;
- iii. Hand over Share/Debenture certificates in any corporate in respect of shares/debentures held by him as on 26.05.2025 to the Bankruptcy Trustee; and
- iv. Provide balances as on 26.05.2025 lying in all his Bank accounts and remit the same to the Bankruptcy account (account opening is in process, till then do not use any funds from the accounts)

The undersigned further sent reminder e-mails to the PG to submit Statement of Financial Position. It was apprised that after rigorous follow up, the same has now been received vide email dated 17.06.2025. Mr. Sanjay Maheshwari further submitted that he has observed some inadvertent errors in the statement submitted by him and that the rectified one will be shared shortly.

(f) Intimation to Creditors

The undersigned vide e-mail dated 30.05.2025 intimated the creditors, SBI and IDBI Bank, who had submitted claim during the PIRP of the PG, about the initiation of the Bankruptcy Process of the Personal Guarantor (i.e. Mr. Sanjay Maheshwari of Corporate Debtor- Saga Automotive India Private Limited) and attached a copy of related order of Hon'ble NCLT dated 26.05.2025. It was also intimated that as directed by Hon'ble NCLT, the Public Notice in respect of the PG has been published in Form C in the following newspapers, in accordance with Section 130 (1) (b) and Section 130 (2) of the Code:

- (i) The Indian Express (English)- Jaipur
- (ii) Prabhat Abhinandan (Hindi)- Jaipur

Another email was sent to the creditors on 30.05.2025 with which copies of published Public Notice dated 30.05.2025 and Format of Form- F were attached with a request to submit their respective claims in the prescribed

format by 06.06.2025 i.e. last date of submission of claims as per Public Announcement dated 30.05.2025.

Furthermore, in accordance with Section 130 (1)(b) of the Code read with Rule 10 of the BPPG Rules and in compliance with the directions of Hon'ble NCLT as contained in its said order dated 26.05.2025, a copy of Notice in Form D was attached to the mail inviting claims from the creditors on or before 06.06.2025.

(g) Opening of Bank Account-

The undersigned apprised the members that in accordance with Regulation 32 (1) of IBBI (Bankruptcy Process for Personal Guarantors to Corporate Debtors) Regulations, 2019 ("BPPG Regulations"), the Bankruptcy Trustee is required to open a bank account in the name of Bankrupt in a scheduled bank.

In view of the stated statutory provision, the undersigned has requested the PGs to submit copies of your **KYC documents, i.e., PAN Card and Aadhar Card** to enable the Bankruptcy Trustee to open the required bank account in a scheduled bank. It was further apprised that the said documents have been received vide email dated 18.06.2025.

(h) Appointment Of Legal Counsel

The undersigned presented the quotation received from Advocate, Abhishek Anand and Kakra & Associates which were duly presented in the meeting through shared screen of Zoom Application. The representative of SBI submitted that they would discuss internally on the appointment of the Advocate and then the resolution for the same be placed for approval by the members. Quotations as received are annexed herewith as an Annexure 2 & 3.

The undersigned also submitted that in terms of Regulation 20 (2) of Bankruptcy Process Regulations, a report on establishment of CoC is to be filed within 3 days from the instant meeting. Accordingly, approval for appointment of legal counsel to file the required Report/Application on

establishment of CoC may be obtained from the members of CoC via email and thereafter a resolution for the same be placed.

(i) Discussion on Appointment of asset tracing agency

The Bankruptcy Trustee apprised that as per provisions of the Code, it is the duty of the Bankruptcy trustee to investigate the affairs of the bankrupt. In view of the same an asset tracing agency was proposed to be appointed for the said purpose.

After detailed discussions and deliberations, it was decided to invite quotations from asset tracing agencies and to be placed in the next meeting for approval.

(j) To amend and ratify the stipulated time of notice of meetings

It was stated that the Bankruptcy Trustee would like to seek approval from the CoC for a reduction in the stipulated time period for notice of CoC meeting from 7 days to minimum 48 hours in terms of Regulation 21(3) of IBBI (Bankruptcy Process for Personal Guarantor to CD) Regulations, 2019 considering that there arises some situation where meeting is required to be convened immediately and serving a notice for 7 days is not feasible. Whereupon it was discussed and decided that the shorter notice period of 48 hours may be fixed for convening the subsequent meetings of CoC.

The resolution to this effect was decided to be put to vote before CoC.

(k) To discuss and approve fee of Bankruptcy Trustee

The undersigned apprised that while giving his consent to SBI for his appointment as Bankruptcy Trustee in the matter of PG, the undersigned has quoted the fee as under:

Professional Fees- The fees as approved for conducting insolvency resolution process against the said PGs shall continue to be paid, i.e., Rs. 35000/- per month per personal guarantor. This fee shall be subject to maximum and within the fees payable in terms of Regulation 4 (2) of the IBBI (Bankruptcy Process for Personal Guarantors to Corporate Debtors), Regulations, 2019, as prescribed in Schedule I thereof.

The undersigned apprised that upon the concurrence of SBI, he had forwarded his consent in required Form A to their legal counsel. Accordingly, it was decided to place resolution of approval of Bankruptcy Fees as consented by the applicant bank before CoC for approval.

(1) To update on the Cost incurred in the matter till date

The Cost/Expenses incurred so far in the process was apprised/placed before CoC, for their consideration and approval and ratification purpose. The summary of the same is as under:

The aforementioned cost was decided to be put to vote before CoC. The same was taken note of.

B. Matters to be Voted upon:

Post deliberations on the aforementioned matters for discussions, the resolutions for seeking approval of Creditors were decided to be put to vote through physical voting sheets to be circulated along with minutes. Accordingly, the matters in the undermentioned form will be placed for voting:

Resolution No. 1-

To discuss, consider and approve reduction in time of notice period from 7 days to 48 hours as per Regulation 21(3) of IBBI (Bankruptcy Process for Personal Guarantor to Corporate Debtors) Regulations, 2019.

"RESOLVED THAT pursuant to Regulation 21(3) of IBBI (Bankruptcy Process for Personal Guarantor to Corporate Debtors) Regulations, 2019, the time period for notice to call a meeting of Committee of Creditors for the subsequent meeting(s) is reduced to minimum 48 hours instead of 7 days."

Resolution No. 2-

To discuss, consider and ratify appointment of legal counsel, Kakra & Associates for obtaining legal services/assistance/consultation including filing of Report on establishment of CoC, various other Reports and Applications from time to time during the Bankruptcy process at a professional fee to be finalized in due course and approval for inclusion thereof in Bankruptcy Process Cost

"RESOLVED THAT the consent of the members of the COC, be and is hereby accorded for appointment of M/s Kakra & Associates as the Legal Counsel for handling the entire bankruptcy Process of the PG on behalf of the Bankruptcy Trustee at the professional fee of Rs. 55,000/- including the 10% clearkage plus expenses as per actuals before Hon'ble NCLT (as per quotation annexed with the minutes)".

Resolution No. 3-

To consider and approve fee of the Bankruptcy Trustee to carry out the Bankruptcy Process of Personal Guarantor which will form part of Bankruptcy Process Cost

"RESOLVED THAT the consent of committee of creditors be and is hereby accorded to approve fee of the Bankruptcy Trustee at Rs. 35,000/- per month till his discharge as Bankruptcy Trustee by Hon'ble NCLT subject to maximum and within the fees payable in terms of Regulation 4 (2) of the IBBI (Bankruptcy Process for Personal Guarantors to Corporate Debtors), Regulations, 2019, as prescribed in Schedule I thereof, as mentioned under agenda no. 5 (m) and inclusion thereof in the Bankruptcy Process Cost of the Bankrupt."

Resolution No. 4-

To approve/ratify the Publication cost for public notice in Form C and other expenses incurred for conducting Bankruptcy Process of Personal Guarantor which will form part of bankruptcy process cost.

"RESOLVED THAT the consent of committee of creditors be and is hereby accorded to approve and ratify expenses/costs aggregating to Rs. 6,300/-towards the expenses incurred during the Bankruptcy Process and for the purpose of inclusion in the Bankruptcy Process Cost of the Bankrupt."

Resolution No. 5-

To approve/ratify the expenses of E-voting agency incurred/to be incurred for setting up e-voting facility and inclusion of expenses in the Bankruptcy process cost thereof.

"**RESOLVED THAT** the E-Voting charges @ Rs. 5,900/- per E-Voting facility plus applicable taxes, if any, from right2Vote, be and is, hereby approved / ratified by Committee of Creditors which would form part of the Bankruptcy Process Cost of the Bankrupt."

There being no other issue to be discussed, the meeting ended at 16:05 HRS with vote of thanks to the chair.
