**Brief on CIRP:**

The Corporate Insolvency Resolution Process (“CIRP”) of the Corporate Debtor commenced vide order dated 11.12.2025 passed by the Hon’ble National Company Law Tribunal, Allahabad Bench, (“NCLT”). The Hon’ble NCLT vide its above-mentioned order dated 11.12.2025 appointed Mr. Naveen Kumar Jain as the Interim Resolution Professional (IRP) to carry out the CIRP, in accordance with Section 16 of the Insolvency Bankruptcy Code, 2016 (“Code”). The CoC in its 1<sup>st</sup> meeting held on 12.01.2026 resolved to appoint M/s ARCK Resolution Professionals LLP, acting through its Authorized Signatory & Designated Partner, Mr. Anil Kohli, as the Resolution Professional in place of erstwhile IRP to carry out the CIRP of the Corporate Debtor. Accordingly, on an application filed before Hon’ble NCLT, **M/s ARCK Resolution Professionals LLP, acting through its Authorized Signatory & Designated Partner, Mr. Anil Kohli (the undersigned) is appointed as the Resolution Professional vide order dated 16.02.2026 read with order dated 19.02.2026** (rectification order) (copy of the order dated 16.02.2026 received on 18.02.2026 and copy of order dated 19.02.2026 received on 22.02.2026).
