n'the heart of Rewari, the political nerve centre of south Haryana, Union Minister Rao Inderjit Singh is staking his entire legacy on the upcoming Assembly elections. Making a hard push for regional dominance, Rao declared in a rally: "This election isn't just any other - it's about asserting the supremacy of south Haryana."

The ambitions of the minister of planning and statistics & programme implementation run deep. South Haryana hasn't delivered a chief minister since 1967, when Rao's father Rao Birender Singh was ousted from power. It's a legacy Rao is determined to reclaim - he's made no secret of his desire for the top seat in Haryana, a position he believes is rightfully his.

But for many voters, the story isn't that simple. "This election is not about south Haryana's supremacy; it's about the personal stakes of Rao and the ruling BJP (Bharatiya Janata Party)," says a visibly frustrated Kapil Singh, a 35-yearold from Rewari.

A BJP supporter since 2014, Kapil now feels disillusioned because of Rao's focus on "personal political gains", especially his push to secure a ticket for his daughter Aarti Singh Rao. "Supremacy means real representation and jobs, not just winning seats for family members," he adds.


For voters like Kapil, Rao's narrative of regional dominance rings hollow. Despite the fact that south Harvana cor
