

Johnson ahead in betting odds

As political leaders focus on a final dash for votes ahead of Thursday's crucial general election, British Prime Minister Boris Johnson is ahead at least

in the betting odds game with a forecast of a majority for his Conservative Party.

The Tories remain the odds-on favourite to win the most

seats, with bets predicting a fairly comfortable majority seats for the ruling party and Opposition Labour Party leader Jeremy Corbyn pegged at distant odds to oust Johnson. The other parties, such as

the Liberal Democrats and Brexit Party, are far behind in terms of popularity in the stakes, indicating a clear two-way Johnson versus Corbyn race to the House of Commons.
