A. BACKGROUND

GVK Gautami Power Limited ("Corporate Debtor" or "CD") was incorporated on 19th August 1996 and is registered at Registrar of Companies, Hyderabad. Its registered address is Plot # 10, Paigah Colony, Phase-I, Sardar Patel Road, Secunderabad, Hyderabad, Telangana-500003. As per its Memorandum of Association, it was engaged in the business of generating, harnessing, developing, purchasing, accumulating, distributing and supply of electricity by setting up hydro and thermal power plants using liquid, gaseous or solid fuels.

Present status of the Company

The Corporate Debtor had availed various credit facilities from several lenders over the years for the purpose of setting up a 469 MW gas based combined cycle power plant and related facilities near Kakinada, Andhra Pradesh (Project). The said loan facilities included rupee term loans of Rs. 1042 Crores and foreign currency loans for US\$ 30 million.

Thereafter, Corporate Debtor in the year 2010, owing to the difficulties faced by the Corporate Debtor in servicing the principal and interest to the then existing lenders, had approached Infrastructure Development Finance Company Limited ("IDFC Bank") for grant of a Rupee Term Loan for partial refinancing of existing loans of the Corporate Debtor (which were obtained from various lenders.)

The Corporate Debtor availed a total of Rs. 803 Crores from the IDFC Bank sanctioned as rupee term loans. However, the total amount disbursed to the Corporate Debtor is Rs. 746,57,08,033/. Due to various defaults committed by the Corporate Debtor, the Corporate Debtor's loan account with the IDFC Bank was declared as a Non-Performing Asset on 15.07.2014 by IDFC Bank.

IDFC Bank thereafter assigned the Corporate Debtor's debt to the Edelweiss Asset Reconstruction Company Limited ("EARCL") vide Assignment Agreement dated 24.08.2018. Later, a loan recall notice was issued by the EARCL to the Corporate Debtor on 21.01.2022 followed by a notice under Section 13(2) of the SARFAESI Act.

Further, the Corporate Debtor not only failed to repay the debt, but also acknowledged the debt by way of One Time Settlement letters issued to IDFC Bank and Loan Revival Letters issued to the IDFC Bank and the EARCL.

Subsequently, due to the failure of the Corporate Debtor to make the payment of the entire outstanding amount, the Edelweiss Asset Reconstruction Company Limited filed the Petition under section 7 of the Insolvency and Bankruptcy Code, 2016 seeking initiation of Corporate Insolvency Resolution Process of the Corporate Debtor.

CORPORATE INSOLVENCY RESOLUTION PROCESS

Upon Adjudication of the matter, the Hon'ble Adjudicating Authority, i.e., National Company Law Tribunal, Bench-1, Hyderabad Bench, admitted the Company Petition i.e., C.P. (IB). No. 391/7/HDB/2022 on 20.10.2023, filed by the Financial Creditor M/s Edelweiss Asset Reconstruction Company Limited, initiating Corporate Insolvency Resolution Process ("CIRP") under Insolvency & Bankruptcy Code, 2016. The Adjudicating Authority appointed-Mr. Anil Kohli as an Interim Resolution Professional (IRP) vide its said order dated 20.10.2023.

Subsequently, the Interim Resolution Professional was confirmed as Resolution Professional ("RP") by the Committee of Creditors ("CoC") in its first meeting held on 20.11.2023 through E-voting that concluded on 13.12.2023.

B. ELIGIBILITY CRITERIA

Following Resolution Applicants (Individually, Jointly or in Consortium) shall be eligible to express interest for submitting Resolution Plan: -

- For Body Corporates and Other Persons: Minimum Net worth of INR 10 crores and above supported by Documentary Evidence as specified in Annexure B of Detailed EOI.
- For Financial Entities including ARCs/NBFCs/AIFs: Minimum Assets under Management or Funds Deployed or Committed funds available for investment of INR 100 crores supported by Documentary Evidence as specified in Annexure B of Detailed EOI
 - *ARCs participation is subject to the rules and regulations of Reserve Bank of India.

In the event of a consortium between applicants belonging to aforementioned two classes having different eligibility criteria, the eligibility would be calculated in proportion to their share in the consortium.

D. INELIGIBILITY NORMS U/S 29A OF IBC

As per Sec 29 A, a person shall not be eligible to submit a resolution plan, if such person, or any other person acting jointly or in concert with such person—

- (a) is an undischarged insolvent;
- (b) is a willful defaulter in accordance with the guidelines of the Reserve Bank of India issued under the Banking Regulation Act, 1949 (10 of 1949);
- (c) [at the time of submission of the resolution plan has an account,] or an account of a corporate debtor under the management or control of such person or of whom such person is a promoter, classified as non-performing asset in accordance with the guidelines of the Reserve Bank of India issued under the Banking Regulation Act, 1949 (10 of 1949) [or the guidelines of a financial sector regulator issued under any other law for the time being in force,] and at least a period of one year has lapsed from the date of such classification till the date of commencement of the corporate insolvency resolution process of the corporate debtor:

Provided that the person shall be eligible to submit a resolution plan if such person makes payment of all overdue amounts with interest thereon and charges relating to non-performing asset accounts before submission of resolution plan:

[Provided further that nothing in this clause shall apply to a resolution applicant where such applicant is a financial entity and is not a related party to the corporate debtor.

Explanation I.- For the purposes of this proviso, the expression "related party" shall not include

a financial entity, regulated by a financial sector regulator, if it is a financial creditor of the corporate debtor and is a related party of the corporate debtor solely on account of conversion or substitution of debt into equity shares or instruments convertible into equity shares [or completion of such transactions as may be prescribed], prior to the insolvency commencement date.

Explanation II.— For the purposes of this clause, where a resolution applicant has an account, or an account of a corporate debtor under the management or control of such person or of whom such person is a promoter, classified as non-performing asset and such account was acquired pursuant to a prior resolution plan approved under this Code, then, the provisions of this clause shall not apply to such resolution applicant for a period of three years from the date of approval of such resolution plan by the Adjudicating Authority under this Code;]

[(d) has been convicted for any offence punishable with imprisonment - (i) for two years or more under any Act specified under the Twelfth Schedule; or (ii) for seven years or more under any law for the time being in force:

Provided that this clause shall not apply to a person after the expiry of a period of two years from the date of his release from imprisonment:

Provided further that this clause shall not apply in relation to a connected person referred to in clause(iii) of Explanation I];

- (e) is disqualified to act as a director under the Companies Act, 2013 (18 of 2013): [Provided that this clause shall not apply in relation to a connected person referred to in clause (iii) of Explanation I;]
- (f) is prohibited by the Securities and Exchange Board of India from trading in securities or accessing the securities markets;
- (g) has been a promoter or in the management or control of a corporate debtor in which a preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction has taken place and in respect of which an order has been made by the Adjudicating Authority under this Code:

[Provided that this clause shall not apply if a preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction has taken place prior to the acquisition of the corporate debtor by the resolution applicant pursuant to a resolution plan approved under this Code or pursuant to a scheme or plan approved by a financial sector regulator or a court, and such resolution applicant has not otherwise contributed to the preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction;]

- (h) has executed [a guarantee] in favour of a creditor in respect of a corporate debtor against which an application for insolvency resolution made by such creditor has been admitted under this Code [and such guarantee has been invoked by the creditor and remains unpaid in full or part];
- (i) [is] subject to any disability, corresponding to clauses (a) to (h), under any law in a jurisdiction outside India; or

(j) has a connected person not eligible under clauses (a) to (i).

Explanation [I]. — For the purposes of this clause, the expression "connected person" means—

- (i) any person who is the promoter or in the management or control of the resolution applicant; or
- (ii) any person who shall be the promoter or in management or control of the business of the corporate debtor during the implementation of the resolution plan; or
- (iii) the holding company, subsidiary company, associate company or related party of a person referred to in clauses (i) and (ii):

[Provided that nothing in clause (iii) of Explanation I shall apply to a resolution applicant where such applicant is a financial entity and is not a related party of the corporate debtor:

Provided further that the expression "related party" shall not include a financial entity, regulated by a financial sector regulator, if it is a financial creditor of the corporate debtor and is a related party of the corporate debtor solely on account of conversion or substitution of debt into equity shares or instruments convertible into equity shares [or completion of such transactions as may be prescribed], prior to the insolvency commencement date;]

[Explanation II—For the purposes of this section, "financial entity" shall mean the following entities which meet such criteria or conditions as the Central Government may, in consultation with the financial sector regulator, notify in this behalf, namely:—

- (a) a scheduled bank;
- (b) any entity regulated by a foreign central bank or a securities market regulator or other financial sector regulator of a jurisdiction outside India which jurisdiction is compliant with the Financial Action Task Force Standards and is a signatory to the International Organisation of Securities Commissions Multilateral Memorandum of Understanding;
- (c) any investment vehicle, registered foreign institutional investor, registered foreign portfolio investor or a foreign venture capital investor, where the terms shall have the meaning assigned to them in regulation 2 of the Foreign Exchange Management (Transfer or Issue of Security by a Person Resident Outside India) Regulations, 2017 made under the Foreign Exchange Management Act, 1999 (42 of 1999);
- (d) an asset reconstruction company register with the Reserve Bank of India under section 3 of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (54 of 2002);
- (e) an Alternate Investment Fund registered with Securities and Exchange Board of India;
- (f) such categories of persons as may be notified by the Central Government.

C. SUBMISSION OF EXPRESSION OF INTEREST

F. Return of EMD-I

- a. The EMD-I of the Applicant, who has not been selected as the Successful Applicant, shall be returned upon occurrence of following events:
 - a) If the PRA is found to be ineligible to be a Resolution Applicant.
 - b) If the PRA does not submit the Resolution Plan till the last date for submission of resolution plan.
 - c) If the Resolution Plan is rejected by the COC
- b. The refundable EMD-I of Successful Resolution Applicant would be adjusted towards the Performance Security.

It is hereby clarified that submission of EOI without the requisite Earnest Money Deposit by the Potential Resolution Applicant till such period as per the terms of the Detailed EOI, may lead to rendering of that particular Prospective Resolution Applicant as ineligible by the CoC, and accordingly, the CoC shall have the right (but not the obligation) to reject such Expression of Interest.

G. Forfeiture of EMD-I

The Resolution Professional shall have the right to forfeit the EMD-I with the consultation of CoC, without prejudice to any other right or remedy that may be available to the Resolution Professional / CoC under this Detailed EOI or Applicable Laws, in the following circumstances:

- a. it is discovered that any information or record provided by such Applicant in EOI, to the Resolution Professional/ his advisors is untrue or incorrect;
- b. the Applicant conceals any material information, makes a wrong statement, misrepresents facts or makes a misleading statement in the EOI or any other document provided to the Resolution Professional or Committee of Creditors;
- c. the Applicant breaches the terms of any of the EOI or terms of any undertakings

provided hereunder;

- d. if the Applicant is found to have made a false or misleading declaration of eligibility under Section 29A of the IBCor terms of eligibility criteria; or
- e. if the Applicant is a Consortium, and the Consortium or any members thereof fails to comply with the conditions set out in herein;
- f. if the Applicant withdraws / unilaterally changes its Resolution Plan before the same is approved by the Committee of Creditors / Adjudicating authority.

The Beneficiary (on the instructions of the CoC) shall have the right to forfeit the Earnest Moneyat any time, without making any reference to the Resolution Applicant, irrespective of any ongoing dispute or litigation. If the right to forfeiture arises after the expiry of the CIRP Period and the CoC as a body does not subsist, then the Beneficiary acting on the instructions of the financial creditors that had 51% voting share in the CoC will have such right of invocation/ encashment/ adjustment/ forfeiture of the Earnest Money Deposit-I for the benefit of the other members of the CoC.
